Item 3B

I've mentioned this before, but the 2021 International Association of Chiefs of Police (IACP) Conference is basically just a venue for police chiefs and officers to share information on new weapons, technology, and tactics to further criminalize communities and infringe on privacy rights. This can be plainly seen in the past when LAPD showcased and highlighted the use of their "data-driven policing" methods and even the Operation LASER and Predpol. As mentioned before, Operation LASER was then shut down in 2019 due to concerns over infringement of human and privacy rights. Predpol was also shut down following community demands.

So basically, the department wants to have more money (more than the half of the city budget they already receive) to go to a conference to share tactics and tools that are known to be controversial and unethical? Why are you allowing them to have more of this money?

Item 4D

This item represents LAPD's After-Action report on the raid and violence they perpetuated on Echo Park a few months ago. I do not know how you as an "oversight" commission continue to believe reports created and submitted by those who were the ones perpetuating the harm and by those who are being investigated-- the police themselves. I find it baffling that you continue to allow LAPD to investigate itself -- this is like allowing the January 6 capitol rioters to write their own self-investigation report and then believing it and not doing anything about it.

As all of us could predict, LAPD's After-Action report continues to minimize and downplay their role in violence and in inflicting harm. You continue to protect the LAPD instead of the people whose voices you're supposed to represent.

Other points related to Item 4D:

* The same model you used in identifying Echo Park Lake as a SARA Project was also used under Operation LASER - the very same Operation LASER that was shut down in 2019 due to concerns over infringement of human and privacy rights. * As equally mind-boggling is the fact that the report itself shows the department spent over \$2 million for the raid on Echo Park - how ironic. This money could have instead been placed towards affordable housing and other community services for the people that your department instead decided to forcefully kick out.

The statements by Commissioner Briggs on his refusal to defund the police is troubling. It's one thing to have personal opinions.
