Comparison of Discipline Imposed. 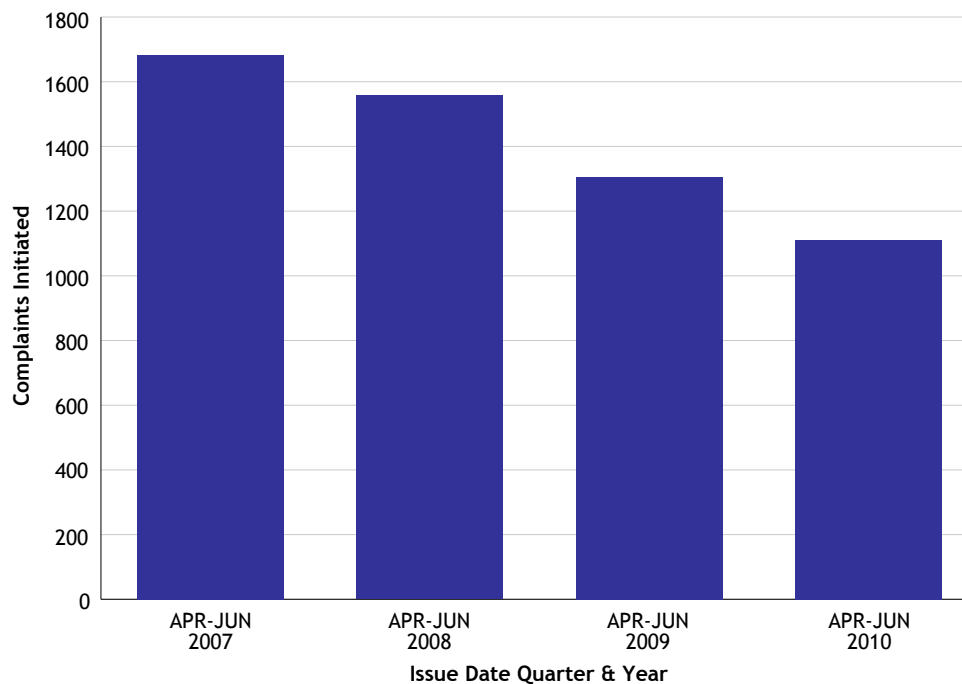
